Following your comments via Jean-Paul Mingasson Daniel and I have substantially reedited the draft of the annex to Part III. With a number of subheadings and a conclusion, the order and the ease with which the presentatin can be followed have, hopefully, improved. The section on the Lamfalussy proposal will probably have to be enlarged, subject to the Committee's discussion of it on March 14, and this has been indicated in the text. On the other hand the paras, in square brackets in the introduction may be scrapped if you so wish.
