As agreed, we have provisionally included the Rapporteurs' note on "Economic and monetary union: The main issues" and accordingly amended the title of Section II of the table of contents. If the Chairman decides against the inclusion of the note you can easily go back to the earlier presentation (i.e. delete the addition "and questions arising in the context of economic and monetary union"). .There are two more points to keep in mind.
